#### **ELECTRICITY SUPPLY ENACTMENT 2024**

ELECTRICITY SUPPLY (COMPOUNDING OF OFFENCES) REGULATIONS 2024

IN exercise of the powers conferred by section 110 of the Electricity Supply Enactment 2024, the Minister makes the following regulations:

#### Citation and commencement

- 1. (1) These regulations may be cited as the Electricity Supply (Compounding of Offences) Regulations 2024.
  - (2) These Regulations come into operation on 3 January 2024.

#### **Compoundable offences**

2. The offences specified in the First Schedule are prescribed to be compoundable offences.

## Offer and acceptance of compound

- 3. (1) An offer to compound an offence shall be made in Form 1 of the Second Schedule.
- (2) A person who accepts an offer to compound a compoundable offence shall accept the offer in Form 2 of the Second Schedule.

#### Payment of compound

4. (1) If an offer to compound an offence is accepted by the person to whom the offer is made, he may pay the compound —

- (a) by cash and such payment shall be delivered personally to the Commission; or
- (b) by money order, postal order, cashier's order, banker's cheque or bank draft payable to the Commission and crossed with the words "Account Payee Only".
- (2) If the payment is made under paragraph (1)(b), it shall be delivered personally or sent by registered post addressed to the Commission.
- (3) The Commission shall issue an official receipt for every payment received under this regulation to the person to whom the offer to compound is made.
- (4) Notwithstanding subregulation (1), the person to whom the offer to compound an offence is made may make payment by electronic means as determined by the Commission from time to time.
